# Scholarships and Grants for Medical Research

The Council of the British Medical Association is prepared to receive applications for the following scholarships and grants.

# Scholarships

Applications are invited for the Ernest Hart Memorial Scholarship and the Walter Dixon Memorial Scholarship (each of the value of £300). These scholarships are given for research on any subject relating to the causation, prevention, or treatment of disease. Applications are also invited for the Insole Scholarship (value £250). This scholarship is given for research into the causes and cure of venereal disease.

Application should be made not later than 31 January 1967, and the scholarships will be tenable for one year beginning 1 June 1967.

The Association will also consider applications for renewal of scholarships currently held. No scholarship may be renewed more than twice.

## Grants

The Association is prepared to make grants up to but not normally exceeding £300 each in value for work in connexion with specific research projects relating to the causation, prevention, and treatment of disease, and to consider applications from current Association scholars for additional grants. Applications should be submitted not later than 31 January 1967, but in certain exceptional cases where money is urgently required on account of unforeseen circumstances applications may, at the discretion of the Council, be considered later in the year.

Applicants for scholarships or grants should state the subject of their research and the means whereby they propose to achieve their object on the appropriate form obtainable from the Secretary, British Medical Association, B.M.A. House, Tavistock Square W.C.1.

The Council of the British Medical Association is prepared to consider the award of the following prizes. Preliminary notice of entry is required on a form of application to be obtained from the Secretary, British Medical Association, B.M.A. House, Tavistock Square W.C.1.

#### Sir Charles Hastings and Charles Oliver Hawthorne Clinical Prizes

These prizes (value £75 and £50 respectively) are intended to promote systematic observation, research, and record in general practice. They will be awarded at the discretion of the Council for the best entries submitted by members of the British Medical Association engaged in general practice.

Entries must be sent to the Secretary, British Medical Association, not later than 31 May 1967.

#### Katherine Bishop Harman Prize

This prize (value £75) is awarded biennially to encourage study and research directed to the diminution and avoidance of the risks to health and life that are apt to arise in pregnancy and childbearing. It is open to any registered medical practitioner in the British Commonwealth, the Republic of Ireland, or the Republic of South Africa, and all members of the Association wherever resident.

Entries must be sent to the Secretary, British Medical Association, not later than 19 May 1967.

## **Occupational Health Prize**

Awarded biennially, this prize (value £50) is to encourage interest and research in the field of occupational health. It is open to any member of the Association who is engaged in the practice of occupational health, either whole- or part-time. Candidates may select their own subject.

Entries must be sent to the Secretary, British Medical Association, not later than 31 May 1967.
