Stress Effect of Antilymphocyte Serum

In the article by Professor E. J. Field and Mr. D. B. Cook (26 April, p. 227) the third line of the fifth paragraph should have read, "... it was possible to make measurements with as little as 0.1 or 0.05 ml. of plasma. . . ." The scale of plasma cortisol in Figure 2 should read from 0 µg. to 80 µg., each step being 10 µg.

L-Dopa in Parkinsonism

In the leading article on this subject (26 April, p. 202) the chemical name of dopamine was wrongly printed as 3-hydroxytryptamine. It should have been 3-hydroxytyramine.
