Chair in Clinical Oncology

The second chair in clinical oncology, endowed by the Cancer Research Campaign, is to be at the University of Glasgow in the Western Infirmary. The new department will consist of a professor and supporting staff for which the Campaign is providing about £500,000, in addition to an annual research grant.

The first chair in clinical oncology in the Campaign's programme of founding five such departments in the next 10 years was established last year at Manchester (see B.M.J., 3 March 1973, p. 561).

J. Sainsbury Research Fellowships

The Royal Society has received £80,000 from the J. Sainsbury Centenary Grant for the support of two research fellowships in human nutrition. The appointments will be for up to five years from 1 October 1974, and will be tenable in any university department or research institution, subject to the approval of the council of the Royal Society,

The J. Sainsbury Centenary Grant was inaugurated in 1969 and since then over £125,000 has been given to support research at five Food Science Technology Departments in the United Kingdom.

Phenacetin

On the advice of the Committee of Safety of Medicines the Department of Health and Social Security is to restrict the sale of phenacetin-containing compounds to pharmacies only from 1 June. It is also proposed that from 1 January 1975 phenacetin should be available only on doctors' or dentists' prescription.
