Pharmacology with few flaws

Lecture Notes on Pharmacology. H F Grundy. (Pp 446; figs; £9·80 paperback.) Blackwell Scientific Publications. 1985.

Most medical undergraduates and many postgraduate membership candidates have had reason to be grateful for Blackwell's *Lecture Notes* series. This, the latest addition to the series, continues the tradition of providing a concise yet comprehensive revision text.

The book is divided unequally into four parts. The first discusses the pharmacokinetic concepts that relate to the absorption, distribution, metabolism, and elimination of compounds and many of the other factors that influence the destiny of a drug. Although the text is well illustrated, there is a considerable variation of style, from enjoyable prose to telegraphic notation. Little background mathematical knowledge is assumed and the content is largely descriptive.

The fundamentals of pharmacodynamics are covered in the second part. The text is augmented by uncluttered and explicit diagrams. Some of the tables, however, are over inclusive. The first chapters in this section cover the pharmacology of cholinergic and adrenergic neurones. There is an excellent review of receptor pharmacology and a discussion of the role of autocoids. The information is pertinent and clearly written. There are chapters on the physiology of and drug action in the central nervous system, the latter also discussing some of the clinical uses of therapeutic agents. The final chapter on membrane stabilisers is tightly packed with detail.

Part three is devoted to systematic pharmacology and, as throughout the book, contains many cross references. This is the largest section and details the pharmacology of the major organ systems of the body. In addition, there are chapters on vitamins and chemotherapy. On this topic it is obviously difficult not to stray into what, arguably, is the domain of clinical pharmacology.

The final section contains an outline of toxicology and drug development and use. The amount of space allocated to these subjects does not reflect their importance in pharmacology.

I enjoyed reading this book and found it to be informative. Despite the inconsistency of style, the information is logically set out and easy to absorb. The format has been well planned and the illustrations contribute to the detail rather than detract from the text. I was disappointed by the section on pharmacokinetics, however, and would have preferred more mathematical detail. There could also have been an expansion of the debate on environmental and genetic influences on drug action. An important factor in drug metabolism, and often in the development of adverse drug reactions or toxic effects, is the existence of genetic polymorphisms in the general population. Genetic differences in metabolic pathways within the population are of relevance to the prescribing doctor as well as the pharmacological scientist.

The chapter on toxicology was very restricted, yet this is a major part of pharmacology and deserves a higher profile. Most physicians would benefit from a general understanding of the mechanisms of toxicity and most pharmacologists should be aware of in vivo and in vitro toxicity tests. There is currently a move, both in society and among experimental scientists, towards replacing in vivo toxicity testing by appropriate in vitro alternatives and this warrants discussion. Correspondingly, the long trek of drug research and development justifies more space. A large amount of time, energy, and money is spent searching for more effective and safer medicines for society. I recommend this book to all undergraduate medical students, pharmacologists, and physicians who want a concise update of a continually expanding subject. No textbook is a perfect synopsis of the subject, particularly if it is written by someone other than oneself, but this book more than adequately fulfils its remit. It complements its stable companion on clinical pharmacology, and, although it does not replace the more turgid reference textbooks of pharmacology, it is an excellent revision text. The author has compressed a substantial amount of information into a book that may be enjoyably and quickly read. It is superb value for money.

Gastroenterology in general practice

Management of Common Diseases in Family Practice. "Gastroenterology." M Lancaster-Smith, C Chapman. Series editors J Fry, M Lancaster-Smith. (Pp 204; figs; £12.95.) MTP Press. 1985.

In 1982 Dr Lancaster-Smith and Mr Ken Williams produced a book, *Problems in Gastroenterology*, published by the same house as this book, and in the main, aimed at more or less the same readership. The text of the new book subdivides the subject matter somewhat differently, but in my view this confers no advantage.

The opening chapters on oesophageal problems are much the same in both books, but better and more clearly presented in the 1982 volume. Then follows three chapters dealing with uncomplicated and complicated peptic ulceration and their surgical management.

In the chapter on uncomplicated ulcer the best part is a flow diagram that elucidates and rationalises the transition from conservative to surgical treatment in the era of H_2 receptor blockade. The chapter on complicated ulcer disease and the chapter on surgical management, while interesting, have limited relevance to the general practitioner except insofar as he may have to manage the long term complications of the various operations that are performed. I think that this subject might have been condensed and included in the general management of peptic ulcer disease. The chapter is enlivened, however, by an excellent flow diagram of the mechanisms of dumping syndromes.

The chapter dealing with acute abdominal pain is one of the best in the book. The authors describe a logical sequence of questions to pose to the patient and highlight those points that enable a differential diagnosis and then a presumptive definitive diagnosis to be made *before* proceeding to examine the patient.

Chronic abdominal pain is not dealt with as crisply as acute pain but is covered comprehensively. It is a pity, and I find it confusing, that the investigations and interpretations of pain due to irritable bowel syndrome are included here rather than in the brief chapter dedicated to the condition.

The chapters on acute and chronic diarrhoea are well presented with enough bacteriology to make investigation of the infectious diarrhoeas an interesting exercise in differential diagnosis. In the section on malabsorption there is a diagram (p 102) summarising the causes of this symptom complex after gastric surgery, and it is one of those instances where one picture is worth any number of words. I was also impressed by the authors' approach to the investigation of patients with malabsorption. Inflammatory bowel disease is well, if somewhat briefly covered, and is followed by a description of diverticular disease and constipation. This chapter is arguably the most useful to the general practitioner. The chapter on miscellaneous gastrointestinal problems deals with the hoary chestnuts that we all meet with regularity: anorexia, abnormal tongue, bad breath, wind, and so on. This is marvellous for the young doctor fresh from hospital where such mundane subjects are rarely discussed.

"Jaundice and Liver disease" remains in this, as in the previous book, the best chapter, sufficiently detailed to give the reader a clear understanding of the physiology and pathology of the various conditions, but at the same time it is simply and clearly laid out. The appendix is also useful with sections recommending information to be given to patients suffering with a variety of gastrointestinal problems.

In summary, a readable book, but not as good as the authors' previous work, which I think was better value and might, with advantage, have been revised and reissued as a second edition.

Beyond the high rise flat

Mental Health and the Environment. Ed H Freeman. (Pp 500; figs; £40.) Churchill Livingstone. 1984.

That doctors in general, and psychiatrists in particular, are often poorly acquainted with sociological and anthropological concepts is surprising as there is wide acknowledgement that illness is related to the way in which individuals interact with their surroundings. Clinical experience teaches that aspects of the environment—jobs, housing, and neighbourhood—play a part in the psychiatric illnesses of our patients, not least because the patients tell us that they do. Nevertheless, perhaps because the published work is so extensive and the issues are so big—political rather than individual most of us do not get beyond nebulous concepts. We are aware that schizophrenia is more common in inner cities and that high rise flats are bad for young families but rarely go much further than that.

That is why this book is so welcome: it brings together in one, admittedly densely packed, volume a wide range of concepts from many disciplines in the sociological and behavioural sciences to consider the relation between mental health and the environment. Although the main focus is on psychiatric illness, other aspects of disturbed behaviour such as criminality and aggression are considered and the broad concept of mental health and ill health is one of the strengths of this book. The problem of definition—when is distress disease?—is not shirked, although it is not allowed to dominate.

The emphasis is on the urban environment: size, density and crowding, noise, housing, criminality, and social pathology, with a particular emphasis on the decaying inner city reflecting the editor's own interest and concern about the decline of Salford. There is a sense of well controlled anger, especially in Dr Freeman's own chapters, notably the section on high rise housing, about the effect of planning decisions by the powerful on the ordinary lives of powerless people.

The book is structured into sections that review the scientific background to the broad concepts, concentrate on specific environmental issues, and provide detailed analysis of individual studies. It ends with a moving chapter about our need for a sense of continuity in our environment.

The picture that emerges is one without absolute answers. Not surprisingly, most chapters conclude that the results of recent research are equivocal. Individual factors, such as density, rate of social change, migration, and noise, seem to be deleterious to mental health, especially if they are combined with other factors both in the environment and in the individual. Evidence for individual variation in vulnerability and sensitivity to outside factors is given, and it is implied that there is an end of the spectrum where mental health is substantially impaired by adverse environmental factors alone. I would have liked to see a section where the evidence that intrapersonal factors increase vulnerability or offer protection against environmental stress was reviewed; I was also surprised that the working environment was not considered.

I would highly recommend this book to all interested in the social aspects of disease and suggest that it is made mandatory reading for students of architecture and town planning. It destroys some myths—for example, that rates of mental illness are higher in towns than in rural areas—and brings in some stimulating and fresh concepts to the debate, including a reference to the mating habits of the Arctic skua. My only warning is, do not take it away to read on holiday—it's too depressing.

In brief . . .

Many people with backache seek help from osteopaths, and the papers published in *Empirical Approaches to the Validation of Spinal Manipulation*, edited by A A Buerger and P E Greenman (\$34.75; Charles C Thomas) and based on a conference on "Manual medicine" held at Michigan State University College of Osteopathic Medicine in 1983, emphasise that the main thrust of assessment and treatment is manipulation.

The first section on the biomechanics of the back is excellent. A paper by G B G Andersson, drawing heavily on the work of Nachemson, gives up to date views, the emphasis being mainly on the intervertebral disc. The second section is also good, with American figures of the epidemiology of backache and occupational back injuries. (The importance of this will be recognised by anyone entering general practice when they discover the disparity between the little time devoted to teaching medical students about backache compared with its prevalence in practice.) The third section on diagnosis, patient selection, and manipulation is on less certain ground. Back pain is referred and may be associated with the unusual condition of referred tenderness; furthermore, the back seems to be a target area for patients with neuroses. Examination is largely subjective, and objective investigations such as radiculography and scans are often unhelpful. With this amount of potential confusion it is easy to produce systems of examination and aetiological theories that are at best obscure and at worst meaningless. Validation on a personal level rests with the individual therapist who discovers to his gratification, and often amazement, that a simple manipulative procedure results in a sudden and spectacular improvement of the patient's signs and symptoms.

General validation must depend on the results of controlled trials, and this is the subject of the fourth section of the book. Useful chapters here are by D Evans and M S Burke. The latter enumerates the requirements for a clinical trial, and Evans reviews 11 clinical trials held between 1964 and 1981 and tabulates the results. Patient selection, treatment, and trial design are so different, however, that not surprisingly no discernible trend can be detected—except possibly that older patients respond better.
