Academic staff salaries confirmed

The Committee of Vice Chancellors and Principals has instructed universities to implement the scales recommended by the doctors' and dentists' review body for clinical academic staff. The award will be staged in line with the NHS award, with a 7% increase from 1 April 1990 and a further 2.5% increase from 1 January 1991.

The CVCP has also reached agreement with the Association of University Teachers on non-clinical academic staff salaries. These will be increased by 9% from 1 May 1990, with a further 1% of the salary bill to be distributed among selected individuals for exceptional performance or to recruit scarce staff.

Council approves advice on "sharps"

The BMA council has approved the latest report from the board of science and education, which is a response to the resolution of the 1989 annual representative meeting: "That to reduce the risk of needlestick injury to patients and staff, medical students should be very well trained in safe disposal techniques for all sharps."

The Code of Practice for the Safe Use and Disposal of Sharps gives advice to all health care workers and to people who are responsible for authorising equipment and drawing up local policies on procedures.*

The code provides a thorough assessment of the risk of sharps injuries, with sections on the transmission of infection, a review of existing studies of incidents, and the relative risks to health care staff in different settings. Guidance is given on appropriate protective measures for staff, changes in equipment and practice, and other means of managing risk. There is also detailed advice on the management of sharps injuries. The need for proper training in the safe handling of sharps as part of a general course on clinical safety in medical schools is emphasised.

Under the Control of Substances Hazardous to Health Regulations 1988 general practitioners and employers in other health care settings have a duty to provide employees with information, instruction, and training on risks to health and the precautions that should be taken. The code of practice includes a checklist for training purposes, which identifies the hazards of sharps in everyday use and the means to prevent sharps injuries.

Some council members were unhappy with the proposal that where a patient was known to have HIV infection or hepatitis B his or her notes should be marked with, for example, a biohazard sign. A member of the working party that drew up the code, Dr J W Chisholm, thought that this was a breach of confidentiality. Normally information was conveyed to other people in the patient's interest; now it was suggested that it was for the protection of health care workers.

Dr S J Richards was particularly concerned about marking patients' notes in general practice, which went outside the NHS. But Dr D E Pickersgill pointed out that the notes were already marked in different ways to show certain clinical conditions such as diabetes.

And the chairman of the board, Sir Christopher Booth, confirmed that it was already current practice to mark patients' notes to identify people who were at risk. Otherwise, it would be necessary to wear gloves when dealing with all patients and this was impractical.

ARM agenda

The agenda for the BMA's annual representative meeting, which will be held in Bournemouth from 25 to 28 June, is published this week as a pull out section.

Guidance on HGV examination

The BMA has issued new guidance for doctors who examine drivers of heavy goods vehicles and those who apply for licences for public service vehicles and taxis. The guidance reminds doctors that they do not have to certify fitness; indeed, there are sound medicolegal reasons for them to avoid giving opinions of fitness. There have been cases in the past where the motor insurer has attempted to transfer liability for damages in an accident to a doctor who has certified the driver as fit.

The guidance is available to BMA members from regional offices.
