- The British Postgraduate Medical Federation would like all house officers who have been asked to complete a questionnaire about their training and workload to return them as soon as possible. He will send all respondents questions on the number, age, sex, and treatment of the patients. One aspect of his study on gout will be to see the extent to which prescribing data about allopurinol may serve as a guide to the prevalence of the condition in a practice population. Neurologists are concerned that they often see patients for the initial diagnosis and not again. In collaboration with East Birmingham Social Services Department and the Department of Neurology at Queen Elizabeth Hospital the organisations have been engaged on an outreach project, which is partly funded by the Department of Health. Two linkworkers have been appointed. The aims of the project are to ensure that the services provided are appropriate and accessible to people from ethnic minority groups and to estimate the prevalence of the conditions by age, gender, and ethnic origin in Birmingham.
