## Heated tobacco and politics in Italy

Big tobacco companies using political links to foster their business is concerning. In Italy, a "sunshine act" proposal to make financial links between healthcare professionals and industry more transparent has been approved by the Chamber of Deputies and is currently being discussed by the Senate for definitive approval.

In the meantime, the Italian Senate has been the stage of a conference on cardiovascular prevention, with the non-conditional support of Philip Morris, discussing among other things the potential benefits of heated tobacco products. Invited experts expressed their interest and support for these products, which can reduce health risks and might help smokers to shift from cigarettes.<sup>2</sup>

Risk reduction strategies should be proposed when adequate evidence is available, which is not yet the case for heated tobacco products, as highlighted by the World Health Organization<sup>3</sup> and Public Health England.<sup>4</sup> This is especially

important when such topics are brought to the attention of politicians to avoid the risks of undue lobbying.
