

not to be overcome by any *manœuvre* nor *coup de main*. The general practitioners, as a body, are liable to be ensnared, because they have paid but little attention to the subject of Medical Reform; still they are safe whilst there is a vigilant "Council of the National Institute" to protect and advance their interests; nevertheless, if a majority of the legally-qualified general practitioners decry the establishment of a new College for themselves, by all means let them remain without one; but I think, that although the Council of the College of Surgeons have succeeded in arresting the progress of Medical Reform since 1815, (during thirty-five years,) yet, that the before named combination or company will not be tolerated by the Government in effecting the same purpose, by "dividing the house against itself," during the next thirty-five, nor even the next five years.
