From this list, and that of last week, therefore, it appears that of the 453 memorialists, 49 attended the Manchester meeting, and 20 the York meeting. The Manchester meeting was attended by 203 members, and the York meeting by 112 members.

It appears by the returns laid before our readers, that 13 memorialists attended the meetings of 1854 and 1855; and that 43 attended only one meeting; so that the whole 453 memorialists have been represented at the last two annual meetings by only 56 of their number.

In giving these facts, we withhold any indication of knowledge as to the extent to which the 453 memorialists represent the opinions of the members who were not at the York meeting, because we have no data of a public character to which we can appeal in support of our opinion. Our report of the proceedings at York will show that Dr. Macintyre, Dr. Dickenson, and others who supported the views of the memorial, had not signed it; and the letter of Dr. Cotton, at p. 820 of this number, proves that all the absent members who approved of that document did not append their names to it. Still, the facts to which we can appeal are too few to justify a general statement.
